## A. Covered Services

## 1. Chiropractic Treatment of Injury or Illness

Covered Chiropractic Services are those within the scope of chiropractic care that are supportive to help Members achieve the physical state enjoyed before an injury or illness and are generally furnished for the diagnosis and/or treatment of a neuromusculoskeletal condition associated with an injury or illness, including the following:

- Examinations
- Manipulation
- Conjunctive Physiotherapy

- X-rays
- Emergency Services

## 2. Acupuncture Treatment of Injury or Illness

Covered Acupuncture Services are those within the scope of acupuncture care that are supportive and Medically Necessary for the treatment of neuromusculoskeletal pain resulting from an injury or illness, or for the treatment of uncomplicated adult asthma (that which is not affected by another condition or disease), allergies, post-operative or chemotherapy nausea and vomiting, nausea of pregnancy post-operative (including dental) pain, fibromyalgia, headaches and low-back pain. Services include the following:

- Acupuncture
- Electro-acupuncture
- Moxibustion
- Cupping
- Acupressure, only when acupuncture is contraindicated
- Emergency Services

#### 3. Emergency Services

Emergency Services are covered for the sudden and unexpected onset of an acute illness, extreme neuro- musculoskeletal pain or accidental injury to the nerv- ous, musculoskeletal and/or skeletal body systems, that, in the reasonable judgment of the Member, re- quires immediate care, the delay of which could de- crease the likelihood of maximum recovery, and for which the Member seeks to secure chiropractic or ac- upuncture services immediately after the onset, or as soon thereafter as practicable. Emergency Services do not require pre-authorization; however, they are subject to Landmark's determination that the Member would reasonably have considered that Emergency Services were required.

Emergency Services rendered by a Non-Participating Practitioner are covered only when the practitioner rendering services can show that the services were Covered Acupuncture Services or Covered Chiropractic Services and were provided to reduce the severity of the condition including pain until a Participating Practitioner could safely assume treatment. Similarly, Emergency Services received outside of Landmark's Service Area will be covered only when the Non-Participating Practitioner rendering services can show that the services were Covered Acupuncture Services or Covered Chiropractic Services and were provided to reduce the severity of the condition including pain until a Participating Practitioner could safely assume treatment. Under the Landmark Plan, emergency care must be transferred to a Participating Practitioner as soon as such transfer would not create an unreasonable risk to the Member's health.

#### B. Second Opinions and Referrals

## 1. Second opinions

On occasion, a Participating Practitioner may require a second opinion, which is for consultation only, from another practitioner. Landmark does not require an authorization for any second opinion. Second opinion initiated by your Participating Practitioner will not count against your maximum annual visits and will not require a Member office visit co-payment. Second opinions initiated by Members will count against the maximum annual visits and will require a Member of- fice visit co-payment.

#### 2. Referrals to non-chiropractic and/or non-acupuncture practitioners

For referrals to non-chiropracticand/ornon-acupuncture practitioners, Members or enrollees of full-service plans or HMOs will be referred to the plan or HMO practitioner network for non-neuromusculoskeletal conditions, conditions not improving with chiropractic and/or acupuncture care, and othersuch services that cannot be provided by another Participating Practitioner.

#### C. Limitations and Exclusions

#### 1. Circumstances Causing Services to be Excluded or Limited

 Services provided by a Non-Participating Practitioner, except for emergencies, or as authorized by Landmark

- b) Services provided outside of Landmark's Service Area, except for emergencies
- c) Services incurred prior to the beginning or after the end of coverage
- d) Chiropractic Services that exceed the maximum covered visits for the benefityear
- e) Charges incurred for missed appointments
- f) Educational programs
- g) Pre-employment, school entrance, or athletic physical exams
- h) Services for conditions arising out of employment, including self-employment or covered under any workers' compensation act or law
- i) Services for any bodily injury arising from or sustained in an automobile accident that is covered under an automobile insurance policy
- j) Charges for which the Member is not legally required to pay
- k) Services rendered by a person who ordinarily resides in the Member's home or who is related to the Member by marriage orblood.
- I) Drugs, vitamins, nutritional supplements, or herbs

#### 2. Specific Services that are Excluded or Limited

- a) Experimental or investigational services
- b) Services for vocational or long-term rehabilitation
- c) Hypnotherapy, behavior training, sleep therapy, or biofeedback
- d) Rental or purchase of Durable Medical Equipment (DME)
- e) Treatment primarily for purposes of weight control
- f) Lab services
- g) Thermography, hair analysis, heavy metal screening, or mineral studies
- h) Transportation costs, including ambulance charges
- i) Inpatient services
- i) Massage or soft-tissue techniques
- k) Advanced diagnostic services, such as MRI, CT, EMG, SEMG, and NCV

#### 3. Chiropractic Only Limitations/Exclusions

- a) Manipulation under anesthesia
- b) Services related to diagnosis and treatment of jaw joint or TMJ disorders
- c) Treatment of non-neuromusculoskeletal disorders
- d) X-rays performed on equipment not certified, registered or licensed by the State of California

## 4. Acupuncture Only Limitations/Exclusions

- a) X-rays of any kind ordered by an acupuncturist
- b) Services related to addiction, including smoking cessation
- c) Services not Medically Necessary as determined by Landmark
